ADDENDUM 6: MYLAN (PTY) LTD

Mylan (Pty) Ltd has been awarded a contract for Abacavir 600mg and Lamivudine 300mg 28 tablets under tender no HP13-2019ARV/01, which is supplementary to RT71-2019.

HP13-2019ARV/01 is supplemental to RT71-2019 (Supply and Delivery of Anti-Retroviral medicines to the State for the Period 01 July 2019 to 31 March 2021). The supplemental contract has been created in terms of paragraphs 18.3, 18.7 and 26.2.1 of the Special Conditions of Contract for RT71-2019.

In terms of paragraph 20c of the Special Conditions of Contract for HP13-2019ARV/01. "Where a bid for an item is received from a supplier awarded the contract for that item in terms of RT71-2019, and the price of such bid is less than that of RT71-2019, then the lower of the two prices will be applied to both RT71-2019 and this supplemental contract."

In order to avoid the same anti-retroviral medicine on two separate contracts, item 51343801-0000 on RT71-2019 is hereby cancelled. The awarded volumes of item 51343801-00000 will be added to the awarded volumes of item 1 on contract HP13-2019ARV/01.

The Contractual Price Adjustment Schedule will be as per the amended HP13-2019ARV/01 CPA Methodology Schedule dated 21 November 2019.

This addendum, therefore, aligns the volumes awarded on RT71-2019 to HP13-2019ARV/01. Please amend your records accordingly.
